## CILCA RECOGNISED TRAINERS

Since 2015, the Improvement and Development Board (IDB) have introduced 'recognised trainers' for the CiLCA (The Certificate in Local Council Administration) qualification.

These trainers are the only individuals delivering official CiLCA training under the Improvement & Development Strategy and are the only trainers who will have access to tailored advice and support from NALC and the SLCC. This means that when candidates see the CiLCA recognised trainer logo, they can be confident that the training they choose will be appropriately delivered.



Ascentis, the awarding body for CiLCA, recommends that candidates attend training to have access to a recognised trainer and assistance in completing their qualification.
