Taken part in the organisation of public meetings designed to inform the community on the Local Plan, conservation area review, traffic management. I often represent the PC at the district planning committee, most recently to ensure the future delivery of public toilets, and to voice PC concerns of a market housing development on public land.

Lobbied the Unitary Authority to change the decision to restrict public speaking at council meetings to just one hundred words. Successful.

Currently lobbying the unitary authority cabinet to revoke the 21 day rule to ensure that small parishes have enough time to adequately consult their community on planning matters, and have time to respond to the LA. Have developed the skill of summarising information, and communicating that information effectively in user friendly language to the wider community.
