In my role as Vice Chair (Finance) I believe I have demonstrated that I have high personal standards with regard to honesty, reliability and commitment by the way in which I have chosen to keep assembly members up to date with the Association's financial circumstances. Finance is not always an easy subject to get across to large numbers of people but I am pleased by the number of members who have thanked me for the way in which I present figures and indeed the rolling three year budget to them.

During the past four years I have deputised for the existing Chair on numerous occasions. I have chaired various meetings, spoken at other CALCs meetings and AGMs, given evidence before a Commons select committee, represented NALC at numerous meetings including two with Lord Gardiner, meet with HRH The Princess Royal on three separate occasions including our last conference in Milton Keynes. All these events have in my opinion gone well and I hope strengthened NALCs position. They have also helped me develop a good working relationships with the staff who know that I am approachable to discuss any problems they may have.

Again in my present role I have already met with many of our major sponsors and developed good relationships especially with BHIB who have recently extended their sponsorship arrangement with us. At our conferences/AGMs prior to the Covid pandemic I always arrived the night before to offer help to the staff in setting up but also to chat with as many sponsors as possible to check they were all happy. These relationships are important and I believe it would be beneficial to the Association for me to continue and build upon these links as Chair of the Association.

For the work done by NALC and the CALCs leading to Parish and Town Councils being fully recognised and acknowledged as the first tier of local government.

NALC has improved its services and reputation over the past few years and our existing Chair will be a hard act to follow. Sue and the management team have set the Association on a journey which I believe is the right path. The Covid pandemic has caused some delays to our improvements but to be frank it has had a positive side in that it has made us rethink how best to deliver our services. As a result:

-Our online events have not only attracted much larger audiences than our traditional style event but they have attracted councillors who have not wished to travel in the past. I appreciate that many people, myself included, prefer face to face events but we need to balance both to reach the optimum numbers.

-I do not believe we need to retain 109 Great Russell Street. It has served its purpose but is now no longer fit for our purpose as I think Covid has shown. Yes we need a presence in London but by way of a smaller property either purchased or rented.

-From a financial view point the Virtual Assembly and committee meetings have been highly successful. Our bottom line figures back this up. I am not suggesting that all meetings continue to be virtual but we need to find the right balance not just because of the finance but also because of the time element as the majority of members spend far more time travelling to and from meetings than at the actual meeting.

-We need to review our committees and the way they conduct business. In some cases I believe they should be issue lead rather than having regular fixed meetings. They should be called upon to give their views on issues/topics relevant to their committee.
