As a member of Yorkshire's Finance and Scrutiny Committee, I have made a significant contribution to budget preparation and in particular to the format of budget reporting, simplifying the process. The scrutiny elements include assisting with the formation of various policies and ensuring that all financial processes of the Associations are adhered to.

The Strategic Working Group, of which I have been a member since its inception, looks, as the name suggests, at the strategic direction of the Associations. One of the first actions was to reduce the number of members serving on the Joint Executive Board, reducing costs and making it a leaner organisation. The Group has examined all aspects of the Associations' performance and has allocated responsibilities to the Finance Committee, the Personnel Committee and the Joint Executive Board.

When I was appointed as Treasurer to the SLCC, a part-time Chief Executive had been appointed and the Society was beginning to invest heavily in training and the numbers of employees was increasing at a pace. I set up a budget reporting mechanism and a computerised payroll using Sage, producing regular reports to the Board.
