### Northumbria in Bloom – Village Entries

I am a founder member of 'Horden in Bloom' which collaborates with the Parish Council and other community groups to put forward entries for 'Northumbria in Bloom' and there has been much success in winning awards.

### Experience of collaboration and partnership working

I am already involved in numerous committees and am accustomed to working in collaboration and partnership with others. I work at many levels, from being a county councillor to my local residents association.

### **School Governor**

I am a School Governor of Cotsford Park Infants and Yohden Primary Schools and the Chair of the latter's Personnel Committee.

### **Residents Association**

I am Vice Chair of Horden Residents Association which is engaged with initiatives with the County Council on strategic development initiatives in order to improve 'run down' areas within our former colliery village.

### Neighbourhood Watch

I am a pro-active member of the Neighbourhood Watch Scheme which has forged strong links with the Police and Community Services and County Durham Police Commissioner.

### **Patient Participation Group**

I am currently chair of the Shinwell Medical Centre Patient Participation Group. This committee works collaboratively with the local doctors, practice manager and staff to promote the services offered to patients.
