Please outline three key achievements, skills or experiences that are relevant to the position applied for (250 words max each)

When I became a Parish Councillor on South Kyme Parish Council in 2008, there were no formal procedures or policies in place. In 2009, I researched, wrote and got my Parish Council to adopt its first ever set of Standing Orders and also a contract of employment and disciplinary procedure for the Clerk. By so doing, the Council became more effective as a body and the position of Clerk was recognised as that of a Council employee with associated employment rights

In addition to the above, I organised the first annual Village Meeting in living memory for South Kyme. Section 137 funding was used to provide refreshments for residents that attended the meeting and as a result of this meeting and Annual Parish meetings in succeeding years, a much better community spirit and cohesion has been achieved.

I am also a founder member of the Village Tidy Volunteer Group, which is promoted and sponsored by the Parish Council to maintain the grass areas and footpaths in the village.

In 2009, I took over the Parish Council accounts and computerised them, producing formal budgets, up-to-date cash book and balance sheets for the council to make sound financial decisions. In the succeeding years, Council spending has increased threefold to provide such things as dog waste bins, litter bins, purchase grass cutting equipment and support large village events to promote South Kyme, purchase equipment for the Community Speedwatch group, including two Speed Indicator Devices.

South Kyme sits astride a river (Kyme Eau) and I have worked to promote the enhancement of the river for leisure. I promoted the setting up of a separate working group for enhancement of the river and I sit on the Kyme Eau Working Group for the Parish Council. This group comprises two members from the Parish Council, members from the Environment Agency and the Sleaford Navigation Trust who are the navigation authority for the river.

Through this group, we have been able to secure funding to build two 70ft mooring stations for Narrow Boats and also provide fishing platforms. The river is now much used for boating, fishing and canoeing. I am currently working on a project to secure funding to provide a purpose built

canoe access point on the river. The Parish Council voted to support funding of £1500 for the Narrow boat mooring, the remaining £40k+ coming from grants.

The moorings have been a great success and each year the village has a boating festival and scarecrow completion in early May which brings the village together.

I am an Engineer by profession and in 1988, with a colleague I set up a small specialist welding company doing work for the oil and defence industries, doing business in Europe, the Middle East, India and the Far East.

I am retired and currently Chairman of my Parish Council and also a District Councillor and Executive Board member for North Kesteven District Council (NKDC), with responsibility for Environmental Health, Waste and Recycling, Building Control and Licensing. I also sit on a number of other committees for NKDC: I am Chairman of a Grants Committee, a member of a Planning Committee, a representative on two Internal Drainage Boards, Council representative on a European Union Funded project, a member of NKDC's Climate Committee, River Slea Committee and I also represent NKDC on the Lincolnshire County Council Waste Partnership committee, which brings together seven District Councils to formulate a joint approach to waste collection and recycling in Lincolnshire.

I am passionate about promoting the benefits that good Parish Councils' can bring to their local communities. With my length of experience as a Parish Councillor and my various roles as a District Councillor, I believe that I have a broad range of experience that would be useful in my role as a member of the Smaller Councils' Committee and could make a positive contribution to promoting ways in which to enhance the roles of Parish Councillors and Councils both within their local communities and within the wider districts as a whole.

Explain why you are standing for this committee (250 words max)

I believe there is real potential for 'parish power'; but there needs to be genuine support for those parishes who lack capacity. Many smaller councils are at a disadvantage in terms diminished capacity. In my view alternative methods need to be developed to enable smaller parishes with reduced capacity to join conversations that could affect better outcomes for their communities.

The thriving parish councils we see through NALC are inspirational, demonstrating achievable, positive outcomes and this is excellent, but this 'parish power' needs to be wider-spread.

The most urgent of issues facing us is Climate Emergency. It is crucial that ALL councils, including the smaller struggling councils, take urgent action to mitigate against Climate Emergency. It is therefore more crucial than ever that methods of empowering these harder to reach parish councils are developed immediately.





I am proud to have sat on this committee for the past nearly 2 years. I am grateful to NALC for having a Smaller Council's Committee (SCC) in place. However I believe there is still room for improvement so that the voices of the many Smaller Councils (which make up the greatest number of parish councils nationally) can be better heard and represented.

I am aware that our current committee make-up is not representative across regions and there is no clear communication route with those who we are said to represent.

The current Committee members are keen to: (1) increase the number of elected members; (2) improve communication to enable the SCC to be more relevant and accessible to Smaller Councils; suggested ways forward could be NALC holding some Virtual Networking events specifically for Smaller Councils and the different County Association Area Committee meetings feeding back pertinent Smaller Councils issues; (3) learn from Qualitative research data of Smaller Councils would greatly help inform the SCC.

Please outline three key achievements, skills or experiences that are relevant to the position applied for (250 words max each)

PREVIOUSLY WORKED AS A CLERK: Although my experience of local government only commenced in 2016 as clerk to a very small parish council, I immersed myself into my role with great enthusiasm; I attended all the available training; it was a 6 month wait for new clerk training, so I mirrored an experienced clerk in a nearby parish and attended various neighbouring parish, town and district council meetings, keen to learn good practice; I attended seminars and conferences facilitated by the Rural Service Network, South West Councils, SLCC, PDC and DAPTC; I helped develop a good network of clerks and councillors who were keen to share expertise (good-practice, model documents and inform each other of important consultations) and work together in the face of shared concerns; it was easy to form an informal cluster of 5 neighbouring parish and town councils in the face of Local Government Reform as connections had already been made, the group continues to meet quarterly working together and sharing common concerns and is proving to be invaluable.

Sat on the Smaller Councils Committee during the past 2 years (see above explanation of why I am standing).

As a lead member of our Environment Working Group, we have made much progress since June 2019 when our Council made its Climate Emergency declaration. Engaging with our community is our current main focus.

Our Parish Council has taken on additional services; negotiated taking on the public toilets along with the revenue-earning residents' car park; it finances the Youth Club, subsidises the Sports Trust; facilitated the setting up of the Community Land Trust.

Please outline three key achievements, skills or experiences that are relevant to the position applied for (250 words max each)

An achievement I am proud of is leading my Parish Council during the COVID-19 pandemic. I was elected as Chairman in May 2020 and oversaw rapid changes in legislation having to at pace implement new measures to enable to Council to function.

On top of this I have to deal with the departure of several Councillors due to non-attendance and the departure of the Clerk. This meant that I had to liaise with the local association to get the relevant information to recruit another clerk and hold interviews virtually. The recruitment was successful with the appointment of a new clerk.

Over the course of my chairmanship the reputation of the Parish Council improved with in May 2021 the Council having its first election for 3 years due to the number of candidates putting their name forward for the vacant seats.

The reputation was improved due to improved communications with the community, with myself taking on media responsibilities, updating our Facebook page and Website, also because of the implementation of a Parish Photograph competition which has showcased the natural beauty of the Parish.

While it was not an easy period to lead especially has was relatively new to being on the Council I can reflect on the period and know that I did a great job of keeping the Council functioning and helping to improve it.

Since becoming active in Parish Councils since November 2019 I have found that a lot of upskilling was required to gain the relevant knowledge to help the council be effective. The Council was formed in May 2018 from the splitting of the former Parish Council into two due to having two distinctive areas. This meant that no sitting Councillor had a wealth of experience or knowledge.

I took it upon myself while chairman to gain knowledge to help the Council and did this by self-funding an Introduction to Local Council Administration (ILCA) qualification. This isn't standard practice for Councillors and is normally done by Clerks. I did the learning in my own time and completed it in April 2021.

This qualification has expanded my knowledge massively and meant while we were between Clerks, I was able to help guide the Council in the interim.

I am proud of gaining the qualification and this has now given me a good basis to expand my knowledge from.

One of my greatest achievements to date has been raising local concerns regarding housing and developments.

In November 2020 as Chairman of the Parish Council I was invited to the Nottingham Association of Local Councils AGM (Annual General Meeting) which was attended by the then Secretary of State for Housing, Communities and Local Government (now Levelling Up, Housing and Communities) MP Robert Jenrick.

During the meeting there was opportunity to ask questions to the Association and Secretary of State so I took this chance to raise concerns which Parishioners and the Parish Council had regarding housing develops and the Greater Nottinghamshire Plan which was detailing areas for new developments on previously unbuilt on land in greenbelt areas.

The response received was promising and well received when reported back the Parish. This is still an ongoing topic for the Parish.
