
## THE NEW MODEL

- Came into effect 1<sup>st</sup> April 2015
- English Heritage Trust = new charity responsible for managing the National Heritage Collection
- Historic England = Government's adviser on all aspects of the historic environment



# Historic England

- Champion England's heritage
- Identify and protect England's most important heritage
- Support change through Constructive Conservation
- Support owners and local authorities to have the expertise to look after England's heritage





# Historic England



A few achievements since April 2015:

- Newly listed > 800 building and places
- Amended > 6,000 existing entries
- Advised on > 22,000 planning or listed building consent cases
- Funded > 300 research projects e.g. Must Farm
- Almost 100,000 pupils engaged in its Heritage Schools Programme
- Achieved the target of removing 25% of sites that in 2010 were on the nation's Heritage at Risk Register



The Transfer of Local Authority Heritage Assets



# War Memorials

- We are playing a tangible part in the WWI centenary commemorations:
  - Listing 2500 war memorials
  - Up to £2.5m in grants
  - Providing guidance and expert advice on conservation, repair and maintenance
  - Delivering training and raising awareness, appreciation and stewardship of war memorials for the next 100 years


# War Memorials

- Up to **£2.5m in grants** is available until 2018:
  - Between £200 and £30,000 per project (and even more in exceptional cases)
  - Up to 75% of eligible costs

- We will list 2500 war memorials by the end of the centenary
- Specialist Conservation Guidance & Advice
- Education programme for schools

## The List

The National Heritage List for England (NHLE) is the only official and up-to-date database of all nationally designated heritage assets, including:

- Listed buildings
- Scheduled monuments
- Protected wreck sites
- Registered parks and gardens
- Registered battlefields
- World Heritage Sites
- Applications for Certificates of Immunity (COIs)
- Current Building Preservation Notices (BPNs)

World Heritage Sites are recorded on the List, but these sites are inscribed separately by UNESCO.
