CLIVE BETTS MP

Clive Betts is Labour MP for Sheffield South East. In 2010 Clive was elected as chair of the Department for Communities and Local Government Select Committee and re-elected for a second term following the 2015 general election. His political interests include economic policy, local and regional government and housing.



BARONESS PARMINTER

Kate Parminter studied theology at Lady Margaret Hall, Oxford. In 1998 Kate became chief executive of CPRE, the Campaign to Protect Rural England, which she led for nearly six years. Kate was created a life peer in July 2010. In the House of Lords she is deputy group leader of the Liberal Democrats, party spokesperson on the environment and was a member of the Select Committee on National Policy for the Built Environment.



LORD PORTER OF SPALDING CBE

Gary Porter was elected to South Holland District Council in 2001, becoming council leader in 2003. Gary chaired the Local Government Association (LGA) Environment and Housing Board for two years, becoming Conservative Group leader and vice-chairman of the LGA in 2011. He was elected LGA chairman in June 2015 and made a life peer in the 2015 dissolution peerages list.
