CiLCA RECOGNISED TRAINERS

Since 2015, the Improvement and Development Board (IDB) have introduced 'recognised trainers' for the CiLCA (The Certificate in Local Council Administration) qualification.

These trainers are the only individuals delivering official CiLCA training under the Improvement & Development Strategy and are the only trainers who will have access to tailored advice and support from NALC and SLCC. This means that candidates can be confident that the training they choose will be appropriately delivered.
